In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

MICHAEL BATTISTA, 19339153, with an address of record is 1200 N. Federal Hwy, Ste 315, Boca Raton, FL 33432-2846, holds an insurance producer license in the State of South Dakota;

MICHAEL BATTISTA is aware that the South Dakota Division of Insurance (Division) has conducted an investigation into their insurance related business;

The Division alleges the following with regard to MICHAEL BATTISTA:

1. MICHAEL BATTISTA sold consumers policies unappointed and/or provided by unlicensed insurance companies and/or through unapproved associations and/or utilizing an unregistered third-party administrator, in violation of SDCL 58-8-1, 58-29D-21, 58-30-167(2)(8)(12), 58-30-176, and ARSD 20:06:42:01;
2. The Director of the Division may revoke MICHAEL BATTISTA's insurance producer license for any one of the above-cited violations;

MICHAEL BATTISTA is aware of and understands the nature of the allegations and has been informed that they have the right to a Notice of Hearing, counsel, and appeal, and that by signing this Consent Order, waives these rights;

In return for MICHAEL BATTISTA agreeing to, signing, and complying with the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL 1-26-20;

MICHAEL BATTISTA waives their right to contest the allegations contained in this Consent Order in any future actions or licensing procedures;

MICHAEL BATTISTA agrees to a monetary penalty in the amount of \$5,000 pursuant to SDCL 58-4-28.1, in lieu of an administrative hearing and Final Decision;

MICHAEL BATTISTA further agrees to conduct business in accordance with the insurance laws and regulations of the State of South Dakota; and

MICHAEL BATTISTA further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that MICHAEL BATTISTA pay a monetary penalty in the amount of \$5,000 payable to "South Dakota Division of Insurance" for deposit in the General Fund of the State of South Dakota; and it is further

ORDERED that MICHAEL BATTISTA abide by the agreements made by them in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
