IN THE MATTER OF SUNKIST JUDSON	INS 26-33318 CONSENT ORDER

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

SUNKIST JUDSON, whose address of record is 480 13th St., SE, HURON, South Dakota 57350 is an individual who is currently licensed as an insurance producer in the State of South Dakota;

SUNKIST JUDSON is aware that the South Dakota Division of Insurance (“Division”) has conducted an investigation;

The Division alleges the following:

1. SUNKIST JUDSON did not have a valid South Dakota driver’s license they applied for a South Dakota Insurance Producer’s license, in violation of SDL 58-30-167(1);
2. SUNKIST JUDSON failed to update their address with the Division within 30 days, in violation of SDCL 58-30-157;
3. Pursuant to SDCL 58-30-167(1)&(2) and 58-30-157, the Director of the Division may revoke SUNKIST JUDSON insurance producer license for violating the insurance laws of South Dakota.

SUNKIST JUDSON is aware of and understands the nature of the charges and has been informed that they have the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for SUNKIST JUDSON agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

SUNKIST JUDSON agrees, in lieu of contesting this matter formally, to the revocation of South Dakota insurance producer’s license and to cease the transaction of insurance business in this state;

SUNKIST JUDSON further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of

determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


By the execution of this Consent Order, SUNKIST JUDSON waives the right to contest the allegations contained in this Consent Order in any future licensing proceedings;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the South Dakota insurance producer's license of SUNKIST JUDSON is hereby revoked; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.


