IN THE MATTER OF WA KYAW	INS 26-32821 CONSENT ORDER

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

WA KYAW, whose address of record is 750 FRANK AVE SE, HURON, South Dakota 57350-2947 is an individual who is currently licensed as an insurance producer in the State of South Dakota;

WA KYAW is aware that the South Dakota Division of Insurance (“Division”) has conducted an investigation;

The Division alleges the following:

1. WA KYAW did not have a valid South Dakota driver’s license when he applied for his South Dakota Insurance Producer’s license, in violation of SDL 58-30-167(1);
2. WA KYAW failed to update his address with the Division within 30 days, in violation of SDCL 58-30-157;
3. Pursuant to SDCL 58-30-167(1)& (2) and 58-30-157, the Director of the Division may revoke WA KYAW’s insurance producer license for violating the insurance laws of South Dakota.

WA KYAW is aware of and understands the nature of the charges and has been informed that she has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for WA KYAW agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

WA KYAW agree to pay a monetary penalty in the amount of \$500, pursuant to SDCL 58-4-28.1, in lieu of contesting the matter formally; and

WA KYAW further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

By the execution of this Consent Order, WA KYAW waives the right to contest the allegations contained in this Consent Order in any future licensing proceedings;


Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that WA KYAW pay a monetary penalty in the amount of \$500, which is to be payable to "South Dakota Division of Insurance" and submitted with this completed Consent Order for deposit in the General Fund of the State of South Dakota; and it is further

ORDERED that should WA KYAW fail to comply with the provisions of this Order, the Division may seek the suspension or revocation of his license at hearing pursuant to SDCL 58-30-167 and Chapter 1-26, or seek other remedies available at law; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
