**ORDER REVOKING
BUSINESS ENTITY LICENSE**

TO: LIFERAFT INSURANCE SERVICES, LLC



Larry Deiter, Director of the South Dakota Division of Insurance (Director), in accordance with SDCL 58-30-167.2 and 58-30-167.3, hereby gives notice that LIFERAFT INSURANCE SERVICES, LLC (Respondent) has violated the Insurance Code of the State of South Dakota and has failed to timely respond to the South Dakota Division of Insurance (Division). Respondent is expressly notified that they are entitled to a hearing pursuant to SDCL 58-30-167.3.

RESPONDENT'S BUSINESS ENTITY LICENSE WILL BE REVOKED UNLESS A HEARING IS REQUESTED IN WRITING WITHIN 60 DAYS OF THIS ORDER.

Therefore, supported by the Exhibits attached hereto, the Director makes the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

1. Respondent, with an address of record is shown above, is a licensed Business Entity in the State of South Dakota. (Exhibit 1).
2. Respondent has been subject to administrative action(s) in other jurisdictions, in violation of SDCL 58-30-167(2). (Exhibit 2-3).
3. Respondent failed to timely report the action(s) to the Division, in violation of SDCL 58-30-193.
4. The Division sent inquiries to Respondent at its address of record regarding licensure matters and no complete response was received, in violation of SDCL 58-33-6. (Exhibits 4-5).
5. To the extent any of the foregoing are improperly designated and are instead conclusions of law, they are hereby redesignated and incorporated herein as conclusions of law.

CONCLUSIONS OF LAW

1. The Director of the Division has jurisdiction over Respondent and the subject matter of this contested case pursuant to SDCL Chs. 1-26 and 58-30.
2. Due to the loss of livelihood from lack of licensure, the Division bears the burden of establishing the alleged statutory violations by clear and convincing evidence. *In re Zar*, 434 N.W.2d 598, 602 (S.D. 1989) and *Brown v. Warner*, 107 N.W.2d 1, 4 (S.D. 1961).
3. The Division established by clear and convincing evidence as attached in Exhibits hereto that Respondent violated SDCL 58-30-193 and 58-33-66.
4. The Division established by clear and convincing evidence that the Respondent's South Dakota Business Entity License is subject to revocation pursuant to SDCL 58-30-167(2).
5. The Division is authorized to issue this Order revoking Respondent's Business Entity License without a hearing pursuant to SDCL 58-30-167.2, and 58-30-167.3.
6. To the extent any of the foregoing are improperly designated and are instead findings of fact, they are hereby redesignated and incorporated herein as Findings of Fact.

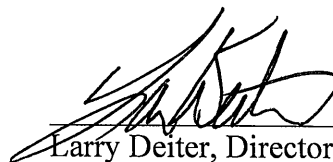
ORDER

Now therefore, good cause appearing from the foregoing, IT IS HEREBY ORDERED, pursuant to SDCL 58-30-167(2), 58-30-167.2, 58-30-167.3, 58-30-193 and 58-33-66, the South Dakota Insurance Business Entity License of LIFERAFT INSURANCE SERVICES, LLC is hereby REVOKED, unless a hearing is requested in writing within 60 days of this Order; and it is further

ORDERED that the Respondent may request a hearing on this Order within 60 days of the date of this Order; and it is further

ORDERED that the Division will issue a Notice of Hearing on this matter within 30 days of a timely written request from the Respondent to schedule a hearing in this matter pursuant to SDCL 58-30-167.3, which shall be conducted according to procedures for contested cases as prescribed in SDCL Chs. 1-26 and 1-26D.
