CONSENT ORDER

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

ZURISADAIRIS SALAZAR, whose address of record is 3853 SW 169th TER, Miramar, FL 33027 is an individual who is currently licensed as an insurance producer in the State of South Dakota;

ZURISADAIRIS SALAZAR is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

1. ZURISADAIRIS SALAZAR was the subject a felony prosecution;
2. ZURISADAIRIS SALAZAR failed to report the felony action to the Division within 30 days, in violation of SDCL 58-30-194;
3. Pursuant to SDCL 58-30-167(2) and 58-30-194, the Director of the Division may revoke ZURISADAIRIS SALAZAR 's insurance producer license for violating the insurance laws of South Dakota.

ZURISADAIRIS SALAZAR is aware of and understands the nature of the charges and has been informed that she has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

By the execution of this Consent Order ZURISADAIRIS SALAZAR neither admits to nor denies any violations of the laws of the State of South Dakota, but waive her right to contest the allegations contained in this Consent Order;

In return for ZURISADAIRIS SALAZAR agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

ZURISADAIRIS SALAZAR agree to pay a monetary penalty in the amount of \$1,000, pursuant to SDCL 58-4-28.1, in lieu of contesting the matter formally; and

ZURISADAIRIS SALAZAR further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

By the execution of this Consent Order, ZURISADAIRIS SALAZAR waives her right to contest the allegations contained in this Consent Order in any future licensing proceedings;


Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that ZURISADAIRIS SALAZAR pay a monetary penalty in the amount of \$1,000, which is to be payable to "South Dakota Division of Insurance" and submitted with this completed Consent Order for deposit in the General Fund of the State of South Dakota; and it is further

ORDERED that should ZURISADAIRIS SALAZAR fail to comply with the provisions of this Order, the Division may seek the suspension or revocation of his license at hearing pursuant to SDCL 58-30-167 and Chapter 1-26, or seek other remedies available at law; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
