**CONSENT ORDER**  
**LICENSE REVOCATION**

In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

SECURE CARE 65, LLC, NPN 18791772, with an address of record is 5251 110TH Ave. N Ste. 114, Clearwater, FL 33760-4837, is a licensed business entity in the State of South Dakota;

SECURE CARE 65, LLC is aware that the South Dakota Division of Insurance (Division) has conducted an investigation into its insurance related business;

The Division alleges the following with regard to SECURE CARE 65, LLC:

1. SECURE CARE 65, LLC supplied false or misleading information to the Division, in violation of SDCL 58-30-167(8) and 58-33-66(2);
2. SECURE CARE 65, LLC permitted unlicensed or unappointed persons to operate in South Dakota, in violation of SDCL 58-30-143, 58-30-171, and 58-30-172;
3. The Director of the Division may revoke SECURE CARE LLC's business entity license for any one of the above-cited violations.

SECURE CARE 65, LLC is aware of and understands the nature of the allegations and has been informed that it has the right to a Notice of Hearing, counsel, and appeal, and that by signing this Consent Order, waives these rights;

In return for SECURE CARE 65, LLC agreeing to, signing, and complying with the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL 1-26-20;

By the execution of the Consent Order, SECURE CARE 65, LLC neither admits to nor denies any violation of the laws of the State of South Dakota but waives its right to contest the existence of this Consent Order in any future actions or licensing procedures with the Division;

SECURE CARE 65, LLC agrees to the voluntary revocation of its business entity license in the State of South Dakota and to cease insurance business in this State; and

SECURE CARE 65, LLC further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the business entity license of SECURE CARE 65, LLC is hereby REVOKED as of the effective date of this Consent Order; and it is further

ORDERED that SECURE CARE 65, LLC abide by the agreements made by it in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further


ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
