IN THE MATTER OF SICURO HEALTH LLC	INS 26-30607 CONSENT ORDER

In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

SICURO HEALTH LLC, NPN 19604727, with an address of record is 100 E Sample Rd, Ste 320, Pompano Beach, FL 33064, holds a Business Entity License in the State of South Dakota;

SICURO HEALTH LLC is aware that the South Dakota Division of Insurance (Division) has conducted an investigation into their insurance related business;

The Division alleges the following with regard to SICURO HEALTH LLC:

1. SICURO HEALTH LLC sold consumers policies provided by unlicensed insurance companies and/or through unapproved associations, and/or utilizing an unregistered third-party administrator, and/or unappointed producers, in violation of SDCL 58-8-1, 58-29D-21, 58-30-167(2)(8)(12), 58-30-176, and ARSD 20:06:42:01;
2. The Director of the Division may revoke SICURO HEALTH LLC's Business Entity License for any one of the above-cited violations;

SICURO HEALTH LLC is aware of and understands the nature of the allegations and has been informed that they have the right to a Notice of Hearing, counsel, and appeal, and that by signing this Consent Order, waives these rights;

In return for SICURO HEALTH LLC agreeing to, signing, and complying with the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL 1-26-20;

SICURO HEALTH LLC waives its right to contest the allegations contained in this Consent Order in any future actions or licensing procedures;

SICURO HEALTH LLC agrees to a monetary penalty in the amount of \$10,000 pursuant to SDCL 58-4-28.1, in lieu of an administrative hearing and Final Decision;

SICURO HEALTH LLC further agrees to conduct business in accordance with the insurance laws and regulations of the State of South Dakota; and

SICURO HEALTH LLC further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that SICURO HEALTH LLC pay a monetary penalty in the amount of \$10,000 payable to "South Dakota Division of Insurance" for deposit in the General Fund of the State of South Dakota; and it is further

ORDERED that SICURO HEALTH LLC abide by the agreements made by it in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.


