



TO: SHAUN SKINNER


Larry Deiter, Director of the South Dakota Division of Insurance (Director), in accordance with SDCL 58-22-22 and 58-22-23, hereby gives notice that SHAUN SKINNER (Respondent) has violated the Insurance Code of the State of South Dakota and has failed to timely respond to the South Dakota Division of Insurance (Division). Respondent is expressly notified that they are entitled to a hearing pursuant to SDCL 58-22-23.

RESPONDENT'S BAIL BONDS PRODUCER LICENSE WILL BE SUSPENDED UNLESS A HEARING IS REQUESTED IN WRITING WITHIN 10 DAYS, FEBRUARY 17, 2026, OF THIS ORDER.

RESPONDENT'S BAIL BONDS PRODUCER LICENSE WILL BE REVOKED UNLESS A HEARING IS REQUESTED IN WRITING WITHIN 30 DAYS, MARCH 5, 2026, OF THIS ORDER.

Therefore, the Director makes the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

1. Respondent, whose address of record is shown above, is an individual who is a licensed bail bonds producer in the State of South Dakota.
2. Respondent was the subject of complaints regarding timely return of bail collateral.
3. Respondent has not timely returned bail collateral in violation of SDCL 58-22-30.
4. Respondent failed to act regarding an outstanding defaulted bond in Lawrence County when required in violation of SDCL Ch. 23A-43 and SDCL 58-22-21(2) & (8).

5. Respondent did not respond to Division inquiries on October 8, 2025; October 29, 2025; November 10, 2025; and January 2, 2026 regarding the foregoing, in violation of SDCL 58-33-66 and 58-33-68.
6. Pursuant to SDCL 58-22-21(2), (4), (6), (7), & (8); 58-22-30; 58-33-66; 58-33-68; and SDCL Ch. 23A-43, the Director of the Division may suspend and revoke SHAUN SKINNER's bail bonds producer license for any one of the above-cited allegations absent a response or request for hearing.
7. To the extent any of the foregoing are improperly designated and are instead conclusions of law, they are hereby redesignated and incorporated herein as conclusions of law.

CONCLUSIONS OF LAW

1. The Director of the Division has jurisdiction over Respondent and the subject matter of this contested case pursuant to SDCL Chs. 1-26 and 58-22.
2. Due to the loss of livelihood from lack of licensure, the Division bears the burden of establishing the alleged statutory violations by clear and convincing evidence. *In re Zar*, 434 N.W.2d 598, 602 (S.D. 1989) and *Brown v. Warner*, 107 N.W.2d 1, 4 (S.D. 1961).
3. The Division has demonstrated by clear and convincing evidence that Respondent violated the insurance and bail laws of this State.
4. The Division established by clear and convincing evidence that the Respondent's South Dakota Bail Bonds Producer License is subject to the issuance of this Order pursuant to SDCL 58-22-21(2), (4), (6), (7), & (8); 58-22-30; and SDCL Ch. 23A-43.
5. The Division is authorized to issue this Order revoking Respondent's bail bonds producer license without a hearing pursuant to SDCL 58-22-22.
6. To the extent any of the foregoing are improperly designated and are instead findings of fact, they are hereby redesignated and incorporated herein as Findings of Fact.

ORDERS


Now therefore, good cause appearing from the foregoing, IT IS HEREBY ORDERED, pursuant to SDCL 58-22-21(2), (4), (6), (7), & (8); 58-22-22; 58-22-23; 58-22-30; and 58-33-66, the South Dakota Bail Bonds Producer License of SHAUN SKINNER is hereby Suspended, unless a hearing is requested in writing within 10 days of this Order; and it is further

ORDERED the South Dakota Bail Bonds Producer License of SHAUN SKINNER will hereby stand Revoked, unless a hearing is requested in writing within 30 days of this Order; and it is further

ORDERED that Respondent may request a hearing on this Order within 30 days of the date of this Order; and it is further

ORDERED that the Division will issue a Notice of Hearing on this matter within 30 days of a timely written request from the Respondent to schedule a hearing in this matter pursuant to SDCL 58-22-23, which shall be conducted according to procedures for contested cases as prescribed in SDCL Chs. 1-26 and 1-26D.


