**ORDER SETTING REPORT  
IMPLEMENTATION TIMELINE**

On June 3, 2015 the Director of the Division of Insurance ("Division") adopted the Examination Report by Order in the Target Market Conduct Examination of Foremost Insurance Company, Foremost Property and Casualty Company, Farmers Insurance Exchange, Fire Insurance Exchange, and Mid-Century Insurance Company ("the Companies") pursuant to SDCL § 58-3-12.

Pursuant to SDCL § 58-3-25, it is hereby ORDERED that within 90 days of the date of this Order, the Companies shall comply with the report recommendations and provide written verification to the Director that each recommendation has been fully complied with, along with a report detailing how each recommendation has been implemented; and it is further

ORDERED the Companies shall comply with the Report recommendations and shall continue to follow the policies and procedures that have been put in place during the course of the examination and those subsequent to the examination's completion; and it is further

ORDERED this Order may not be used by any person for any competitive purpose or used in a manner that would violate SDCL Chapter 58-33.

This Order may be appealed to the Circuit Court and South Dakota Supreme Court pursuant to SDCL Chapter 1-26.
