► Definitions for the Questions on the Next Page Column 1 EMPLOYEE COUNT – All Employees

Total number of persons in this pay group who worked or received pay for any part of the pay period that includes the 12th of the month.

Include:

- Executives and their staff
- Salaried officials of corporations
- Full-time and part-time employees
- Trainees
- Employees on active duty, if receiving pay from employer
- Employees on paid sick leave
- Employees on paid vacation
- Employees on other paid leave

Exclude:

- Outside contractors and their employees
- Pensioners
- Proprietors, owners, or partners of unincorporated firms
- Employees on active duty, if NOT receiving pay from employer
- Employees on leave without pay for entire pay period
- Employees on strike for entire pay period
- Unpaid family members

Column 3 (continued)

Report pay BEFORE employee deductions for:

- Taxes
- FICA (Social Security)
- Health insurance
- Pay deferral plans such as 401K
- Bonds
- Pension
- Unemployment insurance
- Union dues

Include:

- Wages and salaries
- Paid holidays, vacation, sick leave, and other paid leave
- Incentive pay
- Bonuses paid EACH pa period
- Overtime pay
- Tips, if included on W-2s
- Severance, if paid over multiple pay periods

Exclude

- Commissions
- Annual pay for unused leave
- Awards or bonuses not paid each pay period

EMPLOYEE COUNT – Nonsupervisory Employees

Exclude:

- Department heads
- Executives
- Managers
- Officers
- Superintendents

Column 4 COMMISSIONS, PAID AT LEAST ONCE A MONTH

Report separately for "All Employees" and for "Nonsupervisory Employees".

Column 2 WOMEN EMPLOYEE COUNT

Column 5 HOURS, INCLUDING OVERTIME
