Your establishment has been selected to participate in the Occupational Employment and Wage Statistics (OEWS) program, which is conducted by the Labor Market Information Center, South Dakota Department of Labor and Regulation, in cooperation with the U.S. Bureau of Labor Statistics. Your participation is essential for developing the highest quality employment and wage data for the citizens of your state.

### Is the OEWS Report mandatory?

No; however, we strongly encourage participation as employers are the only source of the occupational employment and wage information collected through the survey.

### What information do I need to provide?

All we need from you is the specific job title, a brief description of duties, and the wage rate for each employee who worked during the pay period that included [refer\_date] at the location specified below. Report hourly wage rates for part-time employees, and report hourly wage rates or annual salaries for full-time employees.

#### 2. Report via email

- Download the template from [www.bls.gov/respondents/oes/template.xlsx](http://www.bls.gov/respondents/oes/template.xlsx) and enter the requested information or use a report from your own payroll or personnel system.
- Reply to this email and attach your data file with your IDCF number in the subject line. BLS encourages respondents to encrypt email attachments and send the password in a separate email. Please do not include sensitive information in the body of the email.
