#### **Septic Tank Installer Certification**

To install septic tanks in South Dakota, a person needs to be certified. This certification program ensures that persons installing septic systems understand the design requirements. If you wish to become a certified installer, please complete the following information and submit it to the South Dakota Plumbing Commission at the address above. You will be provided a certification test. A score of 70% or higher is needed to become a certified installer.
