Applicants for any license issued by the commission who desire to be licensed without examination shall apply for their South Dakota license on forms provided by the commission. The applicant shall have been licensed by examination in the state from which he comes, the state shall have licensure laws similar to South Dakota's, and the applicant's work in the state from which he comes shall comply with that state's plumbing code and that state's plumbing code shall be equal to or exceed the South Dakota state plumbing code. The commission will investigate these matters and may require affidavits. The commission shall, in writing, grant the license or notify the applicant of the reasons the license is refused. If the license is refused the

matter shall be treated as a contested case and a hearing date set. The normal examination fee shall accompany the application.

20:53:12:01. Initial application fees. The initial license application fee is as follows:

- (1) For an apprentice license, twenty dollars;
- (2) For an installer and plumber license, fifty dollars; and
- (3) For a contractor license, fifty dollars.

An application fee is non-refundable and must accompany the application.

- (1) For a plumber license, one hundred dollars;

- (4) For a third-year apprentice plumber licensed by examination, fifty dollars.

The initial examination and reexamination fee must be submitted to the commission prior to the examination or reexamination.

20:53:12:03. License and renewal fees. The initial license fee and annual license renewal fee for each license is as follows:

- (1) For an apprentice license, twenty dollars for the first year, thirty dollars for the second year, forty dollars for the third year, and fifty dollars for four or more years;
- (2) For a plumber or installer license, one hundred five dollars;
- (3) For an appliance contractor, manufactured and mobile home contractor, underground irrigation contractor, or water conditioning contractor license, two hundred dollars;
- (4) For a sewer and water contractor license, two hundred thirty-five dollars; and
- (5) For a plumbing contractor license, two hundred seventy-five dollars.

A license is not transferable.

A license renewal application, along with the appropriate renewal fee, must be submitted to the commission for all licenses issued pursuant to SDCL chapter 36-25. Any licensee continuing to perform or offering to perform services licensed under SDCL chapter 36-25, sixty days or more after license expiration is subject to disciplinary proceedings.

A temporary license may be issued only and expires three months from the date of issuance or when the license holder passes the examination required by SDCL 36-25 and article 20:53, whichever occurs first. A temporary license fee is fifty dollars.

A license duplicate fee or replacement fee is ten dollars.

License and renewal license fees must be submitted to the commission prior to the issuance of the license. All fees are non-refundable.
