She also informed the Council the June 30, 2018 Trust Fund balance was above the average high cost multiple (AHCM) threshold triggering the reduced rate table for 2019. The 2019 tax rate notices will be mailed to employers the end of October. An update was provided to the Council on the amount of administrative fee funds received since the rate went into effect January 1, 2018.

Pauline Heier and Secretary Hultman provided an overview of the Unemployment Insurance program for the benefit of the new Council members. The Council received an update and discussion was held on the current state of the UI Trust Fund including financial projections for 2018 and 2019.

The 2018 Annual Report was presented for review by the Council members. Pam Roberts made a motion to approve the report as written with the addition of the new Council members. Tim Fitzgerald seconded the motion. Roll call vote was taken with 6 Yea (Hultman, Fitzgerald, Karst, Owen, Roberts, Sanderson), 3 absent (Anderson, Schmidt, Severson), and 0 Nay. **MOTION PASSED.**
