In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

PRG MULTIFAMILY VALUE-ADDED FUND III L.P.(" PRG MULTIFAMILY") whose address of record is 645 Madison Ave, 5th Fl., New York, NY 10022, is a limited partnership based in the state of New York;

PRG MULTIFAMILY is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation into their securities activities and sales in South Dakota;

The Division has alleged the following:

- 1) On October 18, 2019 the Division received PRG MULTIFAMILY'S Reg. D-506 filing, along with the accompanying fees and late fees.
- 2) In reviewing PRG MULTIFAMILY'S filings, it was discovered that PRG MULTIFAMILY sold and/or solicited securities in South Dakota before it made its Reg. D filing and failed to make the required filings within 15 days of its first sale, in violation of SDCL §§ 47-31B-301, 47-31B-302, and ARSD 20:08:07:03.02;
- 3) The above-cited conduct may be grounds for the denial, suspension, and revocation of PRG MULTIFAMILY's registration and the issuance of a monetary penalty of up to \$10,000 per violation, pursuant to SDCL §§ 47-31B-306 and 47-31B-604;

PRG MULTIFAMILY is aware of and understand the nature of the charges and have been informed that it has the right to notice, hearing, and appeal, and that by agreeing to and signing this Consent Order, agree to the waiver of these rights;

By the execution of this Consent Order, PRG MULTIFAMILY neither admits to nor denies any violations of the laws of the State of South Dakota, but waives its right to contest the allegations contained in this Consent Order;

In return for PRG MULTIFAMILY agreeing to the provisions of this Consent Order, the Division agrees not to proceed to a formal hearing and agrees that this Consent Order will constitute an informal disposition of this matter pursuant to SDCL § 1-26-20;

PRG MULTIFAMILY agrees to a monetary penalty in the amount of \$1,000 pursuant to SDCL § 47-31B-604, in lieu of contesting this matter formally; and

PRG MULTIFAMILY further agrees to conduct itself in accordance with the securities laws and regulations of the State of South Dakota; and

PRG MULTIFAMILY further agrees that this Consent Order may be considered for the purpose of determining an appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that PRG MULTIFAMILY will pay a monetary penalty in the amount of \$1,000 payable to "South Dakota Division of Insurance" for deposit in the general fund of the State of South Dakota; and it is further

ORDERED that PRG MULTIFAMILY will abide by the agreements made by it in this Consent Order; and it is further

ORDERED that this consent order is necessary and appropriate in the public interest and for the protection of investors and is consistent with the purposes fairly intended by the policy and provisions of SDCL 47-31B; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
