In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

VEND TECH INTERNATIONAL, INC. DBA NATURALS2GO ("VEND TECH") whose last known address is 1150 Youngs Rd. Suite 210, Williamsville, NY 14221, is a corporation organized in the State of Idaho and based in the state of New York:

VEND TECH is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation into their Securities-related activities in South Dakota;

The Division has alleged the following:

- 1) VEND TECH has been registered as a business opportunity in South Dakota since 06-08-2021;
- 2) In reviewing VEND TECH's sales and related documents, it was discovered that VEND TECH sold six unregistered business opportunities in South Dakota between August 2014 and August 2020, in violation of SDCL § SDCL 37-25A-8;
- 3) The above-cited conduct may be grounds for the denial, suspension, and revocation of VEND TECH's registration and the issuance of a monetary penalty of up to \$5,000 per violation, pursuant to SDCL §§ 37-5B-41 through 37-5B-43;

By the execution of this Consent Order VEND TECH neither admits to nor denies any violations of the laws of the State of South Dakota, but waives its right to contest the allegations contained in this Consent Order;

Further, VEND TECH is aware of and understands the nature of the charges and has been informed that they have the right to notice, hearing, and appeal, and that by agreeing to and signing this Consent Order, agree to the waiver of these rights;

In return for VEND TECH agreeing to the provisions of this Consent Order, the Division agrees not to proceed to a formal hearing and agrees that this Consent Order will constitute an informal and final disposition of this matter concerning alleged unregistered business opportunities in South Dakota between August 2014 and August 2020, pursuant to SDCL § 1-26-20;

VEND TECH agrees to a monetary penalty in the amount of \$7,500 pursuant to SDCL § 37-5B-43, in lieu of contesting this matter formally; and

VEND TECH further agrees to conduct themselves in accordance with the laws and regulations of the State of South Dakota; and

VEND TECH further agrees that this Consent Order may be considered for the purpose of determining an appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that VEND TECH will pay a monetary penalty in the amount of \$7,500 payable to "South Dakota Division of Insurance" for deposit in the general fund of the State of South Dakota; and it is further

ORDERED that VEND TECH will abide by the agreements made by them in this Consent Order; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
